REGISTERED SEX OFFENDER
ACCOUNTABILITY & CONDITIONAL ATTENDANCE COVENANT

As a Registered Sex Offender who has received Jesus Christ's forgiveness and been baptized, for the benefit of the church and its members, staff, and officers, I agree to the following terms and conditions. I promise the _____ [Church] that I will adhere to the following guidelines for the protection of the children, the church, and my witness:

- I agree to have a chaperone (designated by the Senior Pastor) with me at all times while I am at any church function.
- I will meet the chaperone at a designated area upon arriving at the church.
- I will refrain from ANY (physical, written, or verbal) contact, on and off church premises, with minors or special needs persons who attend the church.
- I will participate in ministries involving adults only.
- I will refrain from being alone with any minor or special needs person on church premises.
- I will refrain from using any part of the church facility where preschool, children's, or youth activities are in session.
- I will not attend children's or youth functions.
- I will not transport any minor or special needs person for any church functions.
- I will use the single occupancy restrooms and coffee facilities provided in the adult Sunday School building, if any.
- I will meet monthly with my accountability partner and yearly with the Senior Pastor.
- I will consult with my accountability partner and _____ staff before committing to participate or serve in any ministry opportunity (e.g., volunteer activity or event). When in doubt regarding my involvement with a specific activity, I will consult the Senior Pastor and/or church staff for permission to participate.
- I agree to limit my participation to the following areas: (*any additions must be pre-approved by _____ staff).

- I agree that the Senior Pastor has permission to share and discuss my being a registered sexual offender with the appropriate staff and leadership of the Church, and with members of church if necessary.
- My probationary agreement does not prohibit me from attending church services.
- I understand _____ [Church] has a Zero Tolerance Policy for violation and that any violations of this Accountability and Conditional Attendance Covenant will result in the revocation of my privilege to attend the church. I have received and reviewed the Church's Policy for Ministry and Involvement of Registered Sex Offenders and I accept, adopt, and agree to abide by the policy. I understand that the Church may deem it appropriate to take legal action to enforce this covenant, including seeking injunctive or other form of relief through the appropriate jurisdiction or tribunal.
